

## **PRIVACY POLICY dicepro.co**

The privacy policy serves as a tool to help us understand what data we collect and for what purpose and what we use it for.

### **Data administrator**

The administrator of your personal data obtained on the site under the domain [www.dicepro.co](http://www.dicepro.co) (hereinafter referred to as "the Site") is Sebastian Gąsior registered at Złotniki 223, 39-300 Mielec, Poland. In addition, in the light of applicable law, Trustees may also be the administrators of your data within individual Services.

### **Processing of personal data**

We process your personal data obtained through the form on the Website [www.dicepro.co](http://www.dicepro.co) , in order to:

1. fulfill your request for contact and present you with our offer, based on your consent
2. marketing, particularly for the purpose of sending the newsletter and the implementation of other marketing campaigns, which is the implementation of our legally legitimate interest. We send such information, of course, based on your consent to electronic communication.
3. for the purpose and to the extent necessary to possibly determine, investigate or defend our content and claims related to the use of the Site, which is the implementation of our legitimate interest.

Providing the data is voluntary but necessary to fulfill your request for contact.

The data obtained in order to fulfill your request for contact will be processed until you withdraw your consent to their processing. You have the right to withdraw your consent at any time, but its withdrawal does not affect the legality of the processing carried out while we were in possession of it.

We will process your data obtained through the form from the Site for marketing purposes, until you express your opposition to such processing. The data necessary for the possible determination, investigation or defense of our claims related to the use of the Site are kept until the claims are time-barred.

### **How long do we plan to store your data**

Your data processed in order to fulfill your request for contact and to send you marketing business information will be kept until you submit your objection.

### **Your Rights**

You have the right to access your data, rectify it, request its removal, limit its processing, object to its processing, including opposition to processing for marketing purposes, as well as their transfer.

In the light of applicable law, Trustees may also be the administrators of your data under the specific Services that you will be interested in. We do not share your data collected via the Site and form with third parties, unless we receive your consent.

### **Cookies**

While browsing the Site, according to the consent given and the configuration of the browser, one or several cookies may be stored by us or a cooperating company (Trusted Partner and our subcontractor) on your device (terminal equipment). Please read the following information about cookies and how to use them.

Cookies are small files that are placed on your computer hard drive when you visit certain websites. They contain information about the device and usually do not contain any personal data. These files cannot be used to infect your device with viruses or other malware.

In cookies, we store basic, anonymous information about users (e.g., an identifier) and data to improve the comfort of using the Website, needed for the optimization and correct display of content contained on websites and advertising campaigns.

As a user of the Site, you may at any time stop providing this information by deleting the cookies stored on your end devices by the Website. To do this, change the settings of the currently used web browser.

It is also possible to configure the browser in a way that will block the installation of cookies for specific websites you have selected or for all websites. However, such settings may result in the loss of some of the Website's functionalities that require the installation of cookies. In accordance with the requirements of the Telecommunications Law, confirmation of the consent for the use of cookies is considered to be the configuration of the browser allowing the installation of cookies on the computer.
